

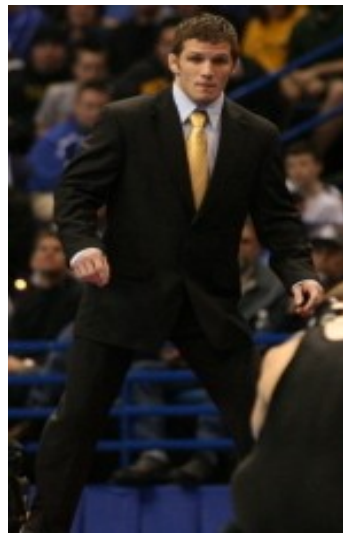

Doug Schwab
University of Northern Iowa

- ◆ New Head Wrestling Coach at the University of Northern Iowa
- ◆ Coach Schwab spent 4 years as an assistant coach for the University of Iowa's national champion wrestling team.
- ◆ Schwab represented the United States at the 2008 Olympic Games in Beijing, China, wrestling freestyle at 145.5 pounds (66 kg).
- ◆ Won the 1999 NCAA title at 141 pounds and finished his collegiate career with 130 wins, which ranks 10th-best in school history.
- ◆ Three-time all-American and Big Ten champion for the Hawkeyes from 1998-2001.
- ◆ Won titles at the 2008 U.S. Olympic Team Trials and U.S. Nationals. In 2007 he won the U.S. Senior Free-style title, earned a bronze medal at the 2007 Pan American Games in Rio de Janeiro, Brazil, and placed fifth at the 2007 World Championships in Baku, Azerbaijan. Schwab's other post-college national wrestling accomplishments include winning the 145.5-pound title at the 2003 Sunkist Kids International Open and earning Outstanding Wrestler honors in the freestyle event. In 2005, Schwab won the 145-pound division of Real Pro Wrestling, earning Outstanding Wrestler honors as part of the champion Iowa Stalkers team.
